INSTRUCTIONS

- ⇒ The Nomination can be made by individuals only applying/holding shares / Debentures on their own behalf singly or jointly upto two persons. Non-individuals including society, trust, body corporate, partnership firm, Karta of Hindu Undivided Family, holder of power of attorney cannot nominate. If the shares are held jointly all joint holders will sign the nomination form.
- ⇒ A minor can be nominated by a holder of shares and in that event the name and address of the Guardian shall be given by the holder.
- ⇒ The nominee shall not be a trust, society, body corporate, partnership firm, Karta of Hindu Undivided Family or a power of attorney holder. A non-resident Indian can be a nominee on repatriable basis.
- ⇒ Nomination stands rescinded upon transfer of Shares/ Debentures or repayment / renewal of deposits made .
- ⇒ Transfer of Shares / Debentures in favour of a nominee and repayment of amount of deposit to nominee shall be a valid discharge by a company against the legal heir.
- ⇒ Only One person can be Nominated for a given folio.
- ⇒ Upon receipt of a duly executed Nomination Form, the Registrar & Share Transfer Agents of the company will register the form and allot a registration number. This Number and Folio No. should be quoted by the Nominee in all future correspondence
- ⇒ The Nomination can be varied or cancelled by executing fresh Nomination Form.
- ⇒ The Company will not entertain any claims other than those of a registered nominee, unless so directed by a Court.
